IT IS HEREBY ORDERED: Bail bonds shall be set according to the following schedule **unless** set otherwise by a Judge.

CRIMINAL CHARGES – WARRANTLESS ARREST	
Concealed weapon - firearm or knife	\$750
Criminal mischief (if \$300 or above)	\$750
Criminal tampering	\$750
Disorderly conduct (W.M.C. §§ 6-2-1(5))	\$750
Engaging in a riot	\$750
False reporting to authorities	\$750
Fraud by check (if \$300 or above)	\$750
Illegal weapons possession	\$750
Obstructing a police officer	\$750
Resisting arrest	\$750
Theft & Theft of Motor Vehicle Parts (if \$300 or above)	\$750
Trespass (in a motor vehicle or the premises are fenced or otherwise enclosed in a manner designed to exclude intruders)	\$750
Violation of Bail Bond Conditions	\$750
Speeding 40+ Miles Per Hour Over the Limit	\$750
CRIMINAL CHARGES – WARRANTLESS ARREST – NO BOND UNTIL HEARD BY COURT	
Any Defendant who refuses to identify themselves or cooperate with verification of identity, such as fingerprinting	No Bond
Any Criminal Charge Which Includes a Domestic Violence Designation	No Bond
Assault	No Bond
Battery	No Bond
Discharge of Firearm	No Bond
False Imprisonment	No Bond
Harassment	No Bond
Indecent exposure	No Bond
Obstruction of the seeking of emergency assistance	No Bond
Protection Order Violation	No Bond
ANIMAL CHARGES – WARRANTLESS ARREST	
Abandoning animals	\$500
Cruelty to animals	\$500
Fighting animals	\$500
Interference (W.M.C. 6-7-16)	\$500
Neglect of animals	\$500
Poisoning	\$500
Potentially dangerous animals	\$500
Vicious animals	\$500
TRAFFIC & RELATED CHARGES – WARRANTLESS ARREST	
Eluding or attempting to elude police officer	No Bond
Involves death or serious bodily injury	No Bond
Unauthorized use of Motor Vehicle	No Bond
Engage in Speed Contest	No Bond
ALL OTHER CHARGES – WARRANTLESS ARREST – PERSONAL RECOGNIZANCE BOND – C.R.S. § 13-10-111.5	
All other charges not listed above	\$750 PR
All matters if not heard within timeframe established in C.R.S. § 13-10-111.5 (non-Domestic Violence charge)	\$750 PR
All matters if not heard within timeframe established in C.R.S. § 13-10-111.5 (Domestic Violence charge)	\$1500 PR
All juvenile arrests	\$250 cosign PR
BOND SETTINGS BY COURT – BOND GUIDELINES AT HEARING	
Criminal Charges with Domestic Violence Designation	\$1,500
All other criminal and traffic charges previously designated as “No Bond”	\$750
All juvenile cases	\$250 cosign PR

- Offenses noted as **No Bond** will have bond set by the Court at the defendant’s next court appearance.
- Nothing in the above schedule prevents the court from issuing a Personal Recognizance (PR) bond or other cash/surety bond amount as appropriate under the circumstances or otherwise required by law.
