PROJECT OVERVIEW

WHAT'S HAPPENING?

The City is designing a replacement **Municipal Courthouse**. The current municipal court is more than 60 years old. Originally constructed as two smaller buildings, which served as City Hall and the police station, the two buildings were merged to form the existing facility over multiple renovations and additions.

WHY?

Because it wasn't purpose-built as a courthouse, the Court faces many **challenges in its daily operations**. It lacks standard safety and security features for modern courthouses and accessibility is inadequate because most of the buildings were constructed before the Americans with Disabilities Act (ADA) was passed.

HOW DID WE GET HERE?

A **Municipal Court study** was conducted in 2022 to evaluate the building and determine the improvements needed to bring the building up to modern safety, security, and ADA standards, while also meeting the operational needs of the court. Based on the information presented from the study, City Council gave staff direction to move forward with the design of a new building. BUILDING HISTORY

1961

The Municipal Court was originally constructed as two separate buildings in 1961 — City Hall and the police station.

1972


In 1972 an addition was constructed to the north of City Hall, which also included a courtyard between City Hall and the addition.

1974

In 1974 an infill project converted the courtyard between City Hall and the Municipal Center into additional interior offices.

1991

In 1991 an addition connected the Municipal Building to the police station, and the entire building was repurposed for its current use as a Municipal Court. Holding cells were also added to the basement during this period.










South Elevation View




North Elevation

Primary material around building perimeter
- 3 **Horizontal Metal Panel**
At cornice of building
- 4 **Composite Metal Panel**
Secondary material to compliment linear brick
- 5 **Decorative Screen Fence**
Provides screening for plaza area
- 6 **Screened Mechanical Enclosure**
Conceals from view along Federal Blvd.
- 7 **Perforated Screen**
Accent material at entry and western stair



WHAT WILL HAPPEN DURING PHASE ONE?


- Install utilities for new building
- Prepare site for new building and pour foundation
- Construction of new Municipal Court building (exterior and interior)
- Construction of new Community Reach Center

HOW WILL THE COURT AREA OPERATE DURING PHASE ONE?


- Court operations, such as jury duty, summons, proceedings, and payments, will continue in the current courthouse while the new building is constructed.
- The Community Reach Center has temporarily relocated to 3621 W. 73rd Avenue. They will remain there until the new building is complete.
- Municipal Park pickleball courts are anticipated to remain open.
- Primary parking for visitors will be along 76th Ave.

WHAT TO EXPECT DURING CONSTRUCTION PHASE ONE

- Perimeter fencing to keep the job site safe and secure
- Cranes and heavy machinery on site
- Heavy truck traffic as building materials are delivered and removed
- Temporary traffic lane and sidewalk closures
- Temporary closures to driveway access on Grove Street
- Temporary water shutoffs, if needed, for new water utilities. Project team will coordinate in advance with those impacted.
- Noise, dust, and vibrations due to construction activity
- Typical work hours are Monday to Friday, 7 am to 5 pm. Some weekend and night work anticipated. Hours will be impacted by holidays, weather, and other construction considerations.
- Municipal Park Playground will be closed
- Temporary visitor parking relocation
- Coordination with Holy Trinity, schools, and neighbors

CONSTRUCTION PHASE TWO

WHAT WILL HAPPEN DURING PHASE TWO?

- Deconstruction of old Municipal Courthouse building
- Deconstruction of old Community Reach Center building
- Installation of new parking facilities, sidewalks, and stormwater detention pond
- Installation of new playground
- Restoration and Installation of new landscaping and community spaces

HOW WILL THE COURT AREA OPERATE DURING PHASE TWO?

- Court operations, including jury duty, summons, proceedings, and payments, will commence in the new courthouse.
- Community Reach Center will relocate to new location on site and resume services.
- Municipal Park pickleball courts will remain open for as long as feasible.
- Primary parking for visitors will be along 76th Ave., new parking for visitors will be available off Turnpike Drive. New staff parking will be available on the north side of the site.

SUSTAINABILITY GOALS

The Westminster Courthouse is planned to be an all-electric Net Zero Ready building

Net Zero (Energy) is a target where a building balances its energy needs with energy produced from renewable, zero-emission sources.

Net Zero Ready is a building that has taken measures to ensure that on-site renewable energy can be provided via a subsequent project.

In the case of the Westminster Courthouse the building is anticipated to be all-electric, with electrical panel space, conduit, and structural strengthening to employ solar both on the roof and on-site in order to achieve net zero.

The Westminster Municipal Courthouse is being planned to achieve LEED Silver certification. The methods to achieve the LEED Silver certification can vary, but initially identified targets include the following:

- EV charging stations
- Native, low-water adaptive plantings
- Demolition and waste management plan for landfill waste diversion
- Energy modeling with target 35% energy cost savings relative to baseline for LEED
- Water-efficient interior fixtures
- Heat island effect mitigation
- Light pollution reduction
- Environmental and health product declarations for selected building materials
- Indoor air quality enhancement


PROJECT FUNDING

CERTIFICATES OF PARTICIPATION (COP)

COPs are a financing tool similar to bonds; however, instead of pledging revenues to pay back the amount borrowed, the Courthouse is pledged as collateral. Like a home mortgage, after all the payments have been made, the City will have free and clear title to the Courthouse.

- ✓ **No Tax Increases**
- ✓ **Due to the City's strong credit rating and tax-exempt status, taxpayers are saving approximately 30% over market interest rates**
- ✓ **Long-term financing, such as COPs, offers intergenerational equity by paying for the Municipal Courthouse over a 25-year period**
