New Business:

<u>Opening of Centralized Recycling Site:</u> Jen presented update on the new Sustainability/ Recycle center via.

- Location is 91st and Harlan.
- First day of operation is Monday the April 22nd and open house is Friday Apr 26th 3pm to 6pm. Pricing for single stream items is free, \$4 for hard to recycle / reuse items (up to 10). Reuse items are items that cannot be recycled. Computers, cells phones, tablets free monitors will have a per pound rate.
- Westminster Sustainability office (Bridger) wrote a grant for a box truck and educational/learning materials.
- Assessing composting availability for the site
- Looking for thoughts on educational opportunities to the community.
- EAB ask if we can help or volunteer answer is yes, will get back to us with details and schedule.
- Highlighted that this facility will not take hazardous waste, but hard-to-recycle materials.

Old Business:

Regional Board Summit Debrief:

- Jen on the Regional meeting one big topic was municipalities providing a singe waste hauler for the community. Need was identified to provide education to the community on the benefits of a single company.
- Maria begins discussion on the need for communication with all groups, taking into consideration sunshine laws and IT support for any platform such at a Google drive.

Revising EAB Mission Statement:

- General consensus is for EAB to start looking at the study session agendas at our meetings to see how we can contribute or frame some of the discussions.
