A motion was made by Merkel and seconded Allen to approve the Sponsorship agreement with Pepsi-Cola Metropolitan Bottling Company, Inc. which provides exclusive distribution and sale of Pepsi-Cola products at various City of Westminster facilities including the new Promenade Ice Centre, and authorize appropriate City Officials to execute the Agreement with Hyland Hills Park and Recreation District, School District 50 and Pepsi Cola. The motion carried unanimously.

## Introduction

City Council is requested to approve an exclusive Sponsorship Agreement with Pepsi-Cola pertaining to the sale of beverage products at City facilities including the new Promenade Ice Centre. The agreement is a joint agreement which involves Hyland Hills Park and Recreation District and School District 50 facilities.

## Summary

Representatives from the City of Westminster, School District 50 and Hyland Hills Park and Recreation District have been negotiating a joint Sponsorship Agreement with Pepsi-Cola. The Agreement calls for the exclusive sale of Pepsi-Cola products at the various entities' facilities where beverage vending machines or fountain service is available. The Agreement calls for sponsorship fees and commission payments to be made by Pepsi-Cola to each of the three entities which, in turn, reflect volume of historic sales or, in the case of the Ice Centre, on projected sales.

Hyland Hills Board of Directors and School District 50 Board of Education have recently approved the Agreement and a signing ceremony is scheduled for Monday, February 22 at 3:00 P.M. at the School District 50 Administration Building.

## Staff Recommendation

Approve the Sponsorship Agreement with Pepsi-Cola Metropolitan Bottling Company, Inc., which provides exclusive distribution and sale of Pepsi-Cola products at various City of Westminster facilities including the new Promenade Ice Centre, and authorize appropriate City Officials to execute the Agreement with Hyland Hills Park and Recreation District, School District 50 and Pepsi Cola.

## Background

There is a growing trend of private sector companies being desirous of entering into exclusive Sponsorship Agreements with local governmental entities such as school districts, park and recreation districts and municipalities. Staff from the City and Hyland Hills initiated an effort to obtain proposals from beverage companies for sponsorship rights at the new Promenade Ice Centre. This process was subsequently expanded to include all City facilities, Hyland Hills facilities and School District 50 facilities. Pepsi-Cola provided the best proposal to the three entities, and negotiations have been underway for the past months to solidify a Sponsorship Agreement.

The key provisions of the recommended Agreement are as follows:

• The term of the Agreement with Pepsi-Cola would be for 15 years, although there are provisions in the Agreement for termination.

- The Agreement covers all facilities that have vending machines or fountain service at City of Westminster, Hyland Hills Park and Recreation District and School District 50 facilities. The new Promenade Ice Centre is included in the Agreement and is a "centerpiece" of the Agreement.
- The Agreement calls for an exclusive relationship with Pepsi-Cola in beverage products sold or dispensed at the stated facilities. It includes carbonated soft drinks, juice and juice-base products, isotonics, ready-to-drink tea, ready-to-drink coffee, bottled water and other non-alcoholic beverage products distributed by Pepsi.
- Pepsi-Cola will pay sponsorship fees on an annual basis to each of the three entities based on the terms spelled out in the Agreement. In the case of the City of Westminster, a sponsorship of \$20,000 per year will be paid for various City facilities and a \$100,000 fee will be paid to the Promenade Ice Centre. (The sponsorship fees do <u>not</u> involve any naming rights).
- Pepsi-Cola will be designated as an "official sponsor" of Hyland Hills, the School District and the City of Westminster, and Pepsi may use this designation in its advertising, promotional and packaging materials subject to the approval of each of the respective entities.
- Pepsi shall have signage on 11 dasherboards, five of which will be located in the main ice rink and three each in the other two ice rinks.
- Pepsi shall work with Hyland Hills and the City to develop a first-class concession area at the Ice Centre. Pepsi-Cola is responsible for providing the necessary vending and fountain dispensing equipment for facilities at each of the three entities.
- Pepsi-Cola will pay commissions to each of the three entities based on the volume of product sold. Prices of the various products are detailed in the Agreement with each of the three entities having the option of setting the vend price on facilities where there is employee access. The commission rate for the Ice Centre shall be 30% and 20% for City facilities with commissions calculated based on gross receipts collected from full-service vending machines installed at facility premises.
- Each entity shall be entitled to inspect the accounting records of Pepsi regarding transactions at subject facilities. Upon request, Pepsi's records shall be available for review on an annual basis for the prior year's transactions by February 1 of the ensuing year.
- Pricing of soft drinks sold to each of the three entities is spelled out with the current pricing being \$12.00 per case for 20 ounce bottles, and \$10.65 per case for one liter bottles.
- Either Party may terminate the Sponsorship Agreement for cause.

This Agreement will provide the City of Westminster a projected \$43,000 per year, which does not include the Ice Centre facility. As additional City facilities are added to the contract, commission sales will be afforded the City by Pepsi-Cola. This will include the City Park Fitness Center, Heritage Golf Course facilities and the planned Northwest Recreation Center.
