Recommended City Council Action

Adopt Resolution No. 35 referring two ballot questions to the Westminster electorate to decide whether two ordinances, that enable the redevelopment of a blighted retail center at Sheridan Boulevard and 72nd Avenue, should be repealed.

Summary Statement

- Council unanimously approved Ordinance 3216 amending the Comprehensive Land Use Plan and Ordinance 3217 rezoning several properties at the southwest corner of Sheridan and 72nd Avenue in order to allow Shoenberg Ventures to redevelop and expand their existing center , in furtherance of the goals of the South Sheridan urban renewal plan. The new anchor tenant proposed was a Wal-Mart superstore.
- On August 9, 2005, citizens of Westminster filed petitions with the City Clerk that requested the Council to either repeal these ordinances or refer the question of their repeal to the Westminster electorate. The City Clerk's initial review of the petitions revealed that they do not contain sufficient valid signatures to require an election, although it is likely that the petitions will ultimately be sufficient.
- Staff previously shared with City Council the preliminary results of the City Clerk's canvassing of the two petitions submitted. While the current number of valid signatures is less than the required ten percent of registered electors, the petitioners are allowed a fifteen day "cure" period to file supplemental petitions with additional or cured signatures. Based on the current number of valid signatures and the number of signatures that can be cured through the supplemental process, the Staff estimates that the petitioners will be able to reach or exceed the Charter's requirement.
- In order to participate in the coordinated elections of Adams and Jefferson Counties, the City Clerk is required to certify Westminster's ballot to the respective County Clerks by September 2, 2005. If the referendum petitions continue to be processed according to the timelines in the City Charter, these referenda would not meet the September 2nd deadline, and a special election would be required.
- Council has the option of referring any question to a vote of the people and by adopting the attached resolution will avoid the substantial costs of, and the confusion and lower turnout typically created by, a special election.

SUBJECT: Resolution Referring the Repeal of Ordinances Nos. 3216 and 3217 to the Voters Page 2

Policy Issue

Should the City place the question of repealing Ordinances 3216 and 3217 before the voters on the regular November 1, 2005, election ballot?

Alternative

City Council could choose to allow the petitioning process to proceed under the timelines provided for in the City Charter. Based on the current canvassing results from the City Clerk's Office, it is highly likely that the petitioners will ultimately obtain sufficient signatures to require the City to proceed with a separate special election or to delay submitting the questions to the voters until the November 2006 election. In the interim, the Ordinances would be suspended pursuant to Charter § 8.13, and the status of the project would be held in limbo.

Background Information

For several years City Staff has been working with the Schoenberg Ventures partners to redevelop their aging shopping center at 72nd and Sheridan. After adopting the South Sheridan Reinvestment Plan in March 2004, the City entered into a Memorandum of Understanding with Shoenberg Ventures for the future redevelopment of that center. The approval, by the Planning Commission and City Council, of the ordinances and the PDP/ODP for the redevelopment of the center with a Wal-Mart superstore and associated commercial uses was consistent with the Plan and the Memorandum, as well as the City's overall goals of economic revitalization of South Westminster. The proposed redevelopment would constitute approximately 25 percent of the South Sheridan urban renewal area.

The City Clerk's estimate of the approximate cost of conducting a special election on the referenda petitions ranges from \$80,000 and \$100,000. Staff does not believe that it would be prudent to spend tax dollars in this manner when referring the question for the November ballot would avoid these costs and most likely allow more Westminster citizens to participate in this decision. The other alternative available to Council, that of waiting until the November 2006 election to place this on the ballot, would cloud the zoning and development regulations for this property for an unreasonable amount of time until such election could be held and the viability of the previously enacted land use ordinances finally determined.

For those reasons, it seems prudent to adopt the attached resolution placing this issue before the voters of Westminster this November.

A RESOLUTION REFERRING TO THE VOTERS OF WESTMINSTER AT THE NOVEMBER 1, 2005, ELECTION THE QUESTIONS WHETHER ORDINANCES 3216 AND 3217, APPROVING A COMPREHENSIVE LAND USE PLAN AMENDMENT AND REZONING CERTAIN PROPERTIES AT THE SOUTHWEST CORNER OF 72ND AVENUE AND SHERIDAN BOULEVARD, SHOULD BE REPEALED

WHEREAS, the City Council is aware that referenda petitions have been submitted to the City Clerk requesting the repeal or referral to the voters of recently adopted ordinances; and

WHEREAS, the statutory requirements for conducting coordinated elections require certification of the municipal ballot by September 2, 2005; and

WHEREAS, the City Council finds that it would be in the best interest of the public to avoid the costs of conducting a separate election to determine the questions presented by the petitioners;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WESTMINSTER:

1. At the regular election to be held on November 1, 2005, there shall be referred to the registered electors of the City the following questions:

A. SHALL ORDINANCE 3216 (Councillor's Bill No.32, Series 2005) AMENDING THE WESTMINSTER COMPREHENSIVE LAND USE PLAN by changing the land use designations for the approximately 0.9 acre property at 7007 Sheridan Boulevard from "R-3.5 Residential" to "Retail Commercial," and for the approximately 15.5 acres located immediately west of the existing shopping center, called Shoenberg Center, at the southwest corner of Sheridan Blvd. and 72nd Ave., from "R-8 Residential" to "Retail Commercial", BE REPEALED?
