SUBJECT: 2011 Golf Division and Standley Lake Fee Changes

PREPARED BY: Ken Watson, Regional Parks and Golf Manager

Recommended City Council Action:

Provide feedback to City Staff regarding the proposed increase in various Standley Lake Regional Park use fees and the fees at the City's golf courses, Legacy Ridge and The Heritage at Westmoor.

Summary Statement

- Standley Lake The Standley Lake Regional Park facility is managed as a cost recovery operation paid for with user fees. In order to continue operating Standley Lake as a cost recovery operation, Staff recommends some adjustments to the fee structure that will be explained in the background section of this staff report.
- Golf Operations During the budget review process, Staff suggested a new offering for the City's golf courses, Legacy Ridge and The Heritage at Westmoor. A flat fee structure on green fees, a new discounted 10-Play Golf Pass and a change to the fee structure in the Corporate Golf Pass structure. Staff is optimistic that these new fee structures will assist with generating additional revenue.
- If City Council concurs with the Staff recommendations, Staff intends to present these fee changes to City Council for formal adoption at the February 28, 2011, City Council Meeting.

Policy Issue

Should City Council approve Staff's recommended increase in fees for Standley Lake Regional Park, Legacy Ridge and The Heritage at Westmoor golf courses?

Alternatives

- 1. Do not authorize the recommended fee increases for Standley Lake Regional Park and phase in increases over the next few years by authorizing the City Manager to increase fees up to 10% annually, based on Resolution # 70, adopted by City Council in September 2000. Since some fees need to be increased by more than 10% to be competitive with other agencies, Staff does not recommend this as a viable solution to funding increasing operating costs and the capital improvement program for Standley Lake Regional Park.
- 2. Do not authorize the recommended flat fee structure, 10 Play Golf Pass and Corporate Golf Pass at Legacy Ridge and The Heritage at Westmoor Golf Courses and continue with the existing green fee categories. Staff does not recommend this since there is a need to generate additional revenue at the golf courses and these new programs will assist with that goal.

Background Information

Standley Lake:

- The Intergovernmental Agreement with the Cities of Northglenn, Thornton, and Farmers Reservoir and Irrigation Company (FRICO) requires the lake operation to be supervised and secured 24 hours per day, seven days per week during the five-month boating season and patrolled from sunrise to sunset the remainder of the year. This is done with four full-time staff members and seasonal employees. Revenue from user fees covers the annual operating expenses of the lake. As operating costs increase, fee adjustments are required. Staff has also identified a need for capital improvements to the park, i.e., parking lot and roadway surfacing, campground, picnic areas and boat dock improvements, etc. If approved, the fee increases proposed by Staff will pay for operating expenses and any surplus revenues will be placed in the Standley Lake capital improvement project account to cover Standley Lake capital projects and park improvements as needed.
- Standley Lake fees were last adjusted in 2007, with the City Manager authorizing some categories to be adjusted between 1% and 10%.
- The City Manager and Parks, Recreation and Libraries Staff have reviewed usage statistics, expenditure budgets, revenue projections, capital improvement needs, and current fees. Staff believes the proposed fees are marketable and will generate additional revenue for the capital improvement fund for Standley Lake Regional Park.

- * Annual powerboat permits include season camping, vehicles day pass and boat storage at the park during the five-month boating season.
- These changes in the various usage categories, outlined above, are anticipated to generate an additional \$15,000-\$20,000 in revenue each year.

Golf Courses:

As part of the ongoing effort to balance the Golf Course budget, Staff continues to evaluate ways in which to make the Golf Courses more efficient and operate within revenues while maintaining a high-quality golf experience.

Due to the poor economy and increasing competition from new municipal golf courses in the area over the last few years, the golf courses have had difficulty maintaining their enterprise status. Almost every account has been reduced and in 2011, 2.0 FTE were also eliminated to help "resize" and also assist with revenue goals. However, even with all the new marketing ideas, improvements to the restroom facilities and budget reductions, the golf courses are still in a challenging financial state. All golf courses in the nation are struggling with the economy and the number of recently-built quality golf courses in the Denver metro area adds to the challenges facing local golf operators.

As City Council is aware, Staff continues to search creative solutions to increase golf rounds, tournament play and overall revenues at the golf courses. Unfortunately, reduced general and tournament play, combined with the significant number of other public golf courses available in the Front Range, have resulted in increased competition for a limited number of golfers.

• Staff is proposing changing the golf fee structures to assist with the goal of maximizing revenue potential during a challenging economy and specifically in the golf industry. The fee changes would be effective for both of the City's two golf courses, Legacy Ridge Golf Course and The Heritage Golf Course at Westmoor. If approved, these fees will become effective immediately. These increased fees are included in the current 2011/2012 revenue projections. Should City Council decline this recommended change, Staff will need to revisit the revenue projections and

likely look at additional cuts and increasing the subsidy from other funds. Also, it must be noted that changing fees does not guarantee increased revenues. Golf is a very competitive and economy-driven business. Staff is making every attempt to increase play and revenue. This is the latest attempt over several years of fee and program changes.

Basically, the new fees will be a flat rate for every golfer, based on their age group and the day of the week they play. Instead of offering two separate categories of every green fee – one for residents and one for non-residents, Staff is recommending one rate that all golfers would pay.

The proposed new rates are as follows:

These rates will be charged for weekday (Monday-Thursdays) or weekend play (Friday, Saturday, Sundays and holidays). However, discounts and specials will continue to be offered via the www.golfwestminster.com website, newspaper advertisements, and other golf publications to allow golfers choices of what they choose to pay to play. The existing marketing plan provides discounts to be offered during non-peak play days and/or low play times. Discounts are not offered during peak play days, i.e. weekends prior to 1 or 2 p.m.

The flat rates will provide the golf courses the greatest opportunity to generate revenue to meet the recovery goals of Westminster's golf course operations. With the new rates, Westminster will not be the highest priced golf course nor will they be the lowest priced, but this change is necessary since golf rounds continue to remain flat (28,000 rounds projected at each golf course/year) while operating expenses, central charges and lease agreements continue to increase.

• Staff is also proposing a new 10 Play Golf Pass to the fee structure. Staff believes this new fee offer could assist with generating additional revenue and allow <u>frequent use guests</u> to take advantage of <u>discounted green fees</u> much like the resident discount green fee offers from the past. With the proposed new flat rate fee structure, offering a 10 Play Golf Pass provides residents and non-residents the option of purchasing 10 rounds of golf at a discount from the advertised rack rate.

^{*}There is no Senior 10 Punch Pass recommended at Heritage because of a senior discount program that is already in place.

- Staff believes that there are advantages for guests and also to the City of Westminster golf courses by offering this type of pass. Guests who choose to purchase the pass will receive a discount from the rack rate. The golf courses will have a captured guest that chooses to return to play ten times over the course of its use, allowing the option for increased residual revenues from the sale of golf cart rentals, range ball sales, merchandise sales and food and beverage sales to the restaurant concessionaire.
- Staff is also proposing a change to the fee structure in the Corporate Golf Pass. Staff believes these new fee structures could assist with generating additional revenue. The Golf Division has been tracking corporate play for the past four years. Corporate play has grown from two Corporate Golf Passes in 2006 to 16 in 2010. Play has increased from 700 rounds in 2006 to over 5,000 rounds as of August 2010. The Corporate Golf Passes have generated positive revenues for both courses. The Golf Division has been monitoring the dollars per player in Corporate Golf Passes in order to maintain revenue goals. In 2010, the dollars per player on passes has dropped below the City's baseline goal of \$30/player and is currently at \$24.72/player.

In order to continue to meet projected revenues, protect tee sheets for general public play and maximize revenues, Staff is proposing changes to Corporate Golf Pass for 2011. Staff believes that the change to three levels of Corporate Golf Pass will allow revenues to either increase or maintain the current level, while continuing to provide a great value for the businesses that can now custom fit their pass to the level required to entertain their clients and employees. Also, by changing the advance reservation time for corporate pass holders from 15 days to 7 days, this further ensures that the general public will have priority for reserving tee times.

SUBJECT: Annexation Boundary for the Area West of Standley Lake

PREPARED BY: Terri Hamilton, Planner III

Recommended City Council Action:

Direct City staff to pursue development of an intergovernmental agreement between the cities of Arvada and Westminster regarding an annexation boundary for the area west of Standley Lake.

Summary Statement

- The City of Westminster has interest in the type of future development that may occur west of Standley Lake, as there could be resulting impacts on the water quality of Standley Lake.
- The City of Westminster may desire to establish an annexation boundary with the City of Arvada to define potential areas of annexation by both cities in the area west of Standley Lake.
- Westminster staff has held informal discussions with Arvada staff regarding development of an annexation boundary for the area west of Standley Lake and Arvada staff appear to be receptive to the idea
- If City Council concurs, Staff will proceed with more formal discussions with Arvada Staff to draft an intergovernmental agreement establishing an annexation boundary for the area west of Standley Lake.

Policy Issue

Should Westminster enter into an intergovernmental agreement (IGA) with the City of Arvada to establish an annexation boundary for the area west of Standley Lake?

Alternative

Do not pursue establishment of an annexation boundary with the City of Arvada for the area west of Standley Lake. This alternative is not recommended as it is to the benefit of Westminster to obtain agreement with Arvada regarding areas of potential annexation, thereby having a greater ability to influence future development patterns and potential impacts on the water quality of Standley Lake.

Background Information

Westminster City staff has had informal discussion with Arvada staff regarding development of an annexation boundary for the area west of Standley Lake. Arvada staff is receptive to the idea. The purpose of identifying an annexation boundary is to establish agreement between the two cities regarding future areas of annexation, enhancing the ability of the cities to achieve common goals and to protect respective interests. Identifying an annexation boundary will assist in defining a logical demarcation line between Westminster and Arvada and protecting the existing rural residential character for lands that may fall within the Westminster annexation area.

The establishment of an annexation boundary in this area will assist Westminster in the protection of its interests regarding future growth and water quality near Standley Lake. The Westminster Comprehensive Land Use Plan (CLUP) indentifies that the City would like to see that the current unincorporated areas west of Standley Lake remain vacant or at low densities, and to protect the water quality in Standley Lake. The mechanism for establishment of an annexation boundary between the two cities would be accomplished by an intergovernmental agreement. A copy of the currently proposed annexation boundary map is attached.



SUBJECT: Adams School District No. 50 Career Enrichment Park Concept Plan

PREPARED BY: Tony Chacon, Senior Projects Coordinator

Recommended City Council Action:

Authorize Staff to continue planning efforts and pursue developer interest in coordination with Adams School District No. 50 relative to adaptive reuse and development of the CEP and adjoining privately held property.

Summary Statement

- The Career Enrichment Park (CEP) is located at the northeast corner of 72nd Avenue and Lowell Boulevard and currently houses two schools and a resource center operated by Adams County School District 50 (District), and Crown Point Charter School.
- Three of the buildings on the campus are of historic significance with two already being listed on the National Register of Historic Places (the former Union High School and DeSpain School originally known as Harris School) and the third is eligible for historic designation.
- Given the age of the buildings on the CEP campus and changing curricula needs and desires, the District is evaluating the future disposition of the property and buildings.
- The City hired Perry-Rose, LLC, a planning/development firm to prepare a plan for the adaptive reuse of the historic structures and development of the remainder of the CEP site on the northeast corner of 72nd Avenue and Lowell Boulevard in South Westminster.
- The plan also considered privately owned property along 72nd Avenue and Meade Street immediately adjacent to the CEP site.
- The conceptual development plan calls for the preservation and adaptive reuse of the three historic buildings on the site, which could include affordable residential units and studio space for artists.
- Per the plan, the area could eventually provide for 120 multi-family units (apartments and/or condominiums), 82 townhomes, 56,000 square feet of office/retail, 7,000 square feet of restaurant, and about 20,000 square feet of artist and/or recreational space.
- The plan includes a community pocket park adjacent to Lowell Boulevard and an extensive "green" pedestrian network.

- The plan can be implemented in a number of phases to meet the District's use needs and market conditions relative to development opportunities.
- The concept plan was recently presented to the School District board by District staff.

Expenditure Required: None

Source of Funds: N/A

Policy Issue

Should the City pursue a developer(s) to provide adaptive reuse of the existing historic buildings and redevelopment of the remainder of the CEP site and adjoining commercial property along 72nd Avenue?

Alternative

The City could choose not to involve itself in promoting redevelopment of the property and rely solely on the School District to pursue redevelopment opportunities. Staff recommends this alternative not be pursued as a partnership between the City and the School District will likely be critical to making redevelopment viable and an asset to the community.

Background Information

The property referred to as the Career Enrichment Park, located at the northeast corner of 72nd Avenue and Federal Boulevard (Attachment A), is owned by School District 50. There are three historic structures located on the property, all of which are currently used by the District. The historic structures include:

- The Harris Park (aka DeSpain) School building;
- The Union High School building; and,
- The original Westminster High School building.

The Harris Park School and Union High School buildings are listed on the National Register of Historic Places. The Westminster High School building is eligible for inclusion on the National Register. The District currently operates Hidden Lake High School out of the original Westminster High School building, and a special needs education program out of the Union High School building. The Harris Park School serves as a central one-stop registration and resource center for parents registering their children into any of the schools in the District. The District also owns a more modern, metal-clad building centrally located on the CEP site, which up until more recently housed the Crown Pointe Charter School. The Crown Pointe Charter School no longer occupies the property having relocated into a new school it recently constructed at 85th Avenue and Federal Boulevard. Further, the District has expressed interest in vacating the Union High School building as early as this year, and is looking at the possibility of relocating Hidden Lake High School out of the Westminster High School building and into the vacated charter school building. This would leave two of the three historic buildings available for possible sale and adaptive reuse in a relatively short time frame. Given these changes, the District is seriously looking at the possibility of selling all or a portion of the CEP property.

These potential changes provided the opportunity for the City and District to collectively look at the future reuse of the CEP site. From the City's perspective, redevelopment of the CEP, incorporating the restoration and adaptive reuse of the historic buildings, would serve as a catalyst for other new development activity in the South Westminster neighborhood. With this in mind, Staff hired planner/developer, Perry-Rose LLC, to prepare a plan for the reuse of the property. Perry-Rose LLC is a nationally renowned, locally-based, development company that focuses its efforts on inner-city properties with an emphasis on adaptive reuse of buildings, green-build and affordable housing. Perry-Rose LLC developed the Highland Garden development at Tennyson Street and 38th Avenue in north Denver (formerly the original Elitch Gardens amusement park.) The principals of the company are Chuck Perry, locally based, and Jonathan Rose out of New York. Mr. Rose is well known for his socially philanthropic endeavors in challenged inner-city neighborhoods. Through the planning process Perry-Rose LLC concluded that the site offered a great development opportunity relative to revitalization of the neighborhood. Perry-Rose LLC was particularly intrigued by the potential for adaptive reuse of the three historic buildings along with integrated new development of the remainder of the site.

The resulting conceptual development plan (Attachment A) was developed by Perry-Rose LLC based upon the following agreed to principals:

- The plan should allow for development to be phased in a manner allowing the District to operate on the site as needed;
- The three historic structures are to be preserved and improved, to the best extent possible, for adaptive reuse;
- The plan should accommodate sufficient density and appropriate land uses to ensure its financial viability, but in a manner that is sensitive to the character of the adjacent neighborhood;
- The plan should be pedestrian friendly; and,
- The plan should reflect New Urbanist design principals similar to those used in the creation of the Bradburn project in the north part of Westminster.

Based on these principals, the plan includes the following concepts:

Adaptive Reuse of Historic Buildings

The entire Union High School building on 72nd Avenue provides an adaptive reuse opportunity for residential lofts (possibly for artists) and/or office uses. The large gymnasium space provides an opportunity for use in conjunction with a fitness center or a large restaurant.

The Harris School on the corner of 72nd Avenue and Lowell Boulevard would be a prime space for boutique retail or restaurant use. Much of the more recently improved parking area between the Union High School building and the Harris School could easily be used in support of these uses. The District could also continue its uses within the building until such time as it chose to vacate the premises.

The Westminster High School building at 73rd Avenue and Lowell Boulevard also offers a creative reuse opportunity in support of the artist community. A major component to reuse of the building would likely include some residential uses, possibly as affordable artist live/work space. In conjunction with this concept, art gallery and retail space could be incorporated into the building. The large commercial kitchen further provides an opportunity for a co-housing project, possible culinary arts training, and/or catering. Another idea may be to use the kitchen as co-op space for small

restaurants the City is trying to establish in the neighborhood. The east end of the building, added on as a second phase to the original building, may provide an opportunity to create a unique complex that blends the historic origin of the building with some new development making it more financially viable to improve and reuse the entire building.

Demolition of Structures

The plan does propose the eventual demolition of several structures on the property. The metal buildings immediately adjacent to the Union High School building along the north side would be demolished to make room for some new residential development.

At such time the District determines the old Crown Pointe building is no longer needed, the plan contemplates its demolition to accommodate residential development. The final demolition would be the small brick garage building immediately east of the old Westminster High School building.

Street Extensions

The plan provides for the eventual construction of up to three streets through the site. A north-south street is proposed to be extended immediately east of the Union High School building and west of the Crown Pointe charter school building connecting 72nd Avenue with 73rd Avenue. This is needed to provide better vehicular and pedestrian access to the center of the CEP site and provide for looping of the utilities. A second street would run east-west connecting Irving Street with the new proposed north-south street. This would provide circulation and utility access to the proposed residential development along the eastern part of the CEP site. The plan also gives consideration to the construction of a street off of Lowell Boulevard that would interconnect with the Irving Street connection. Should it be determined that a this street connection not be needed it would then serve as either an expansion of the adjacent pocket park or provide a co-use area designed to accommodate joint pedestrian/vehicular use.

Parks and Open Space

The plan provides for a small pocket park adjacent to Lowell Boulevard that provides support for uses within the Westminster High School Building, planned residential to the south of the park, and the general public along Lowell Boulevard. The plan also provides for a green pedestrian corridor that would finalize a prominent pedestrian connection from the historic commercial center along 73rd Avenue east of Bradburn Boulevard to the Westminster Plaza shopping center and the Irving Street Library and Park.

General Land Uses

The land uses were distributed into four general development areas so as to allow development activity to be phased in over many years. Planning Areas A, B, C and D collectively represent property owned exclusively by the District and known as the CEP site. Planning Area E represents privately held property abutting the CEP site that provide future opportunity for redevelopment at such time market conditions make redevelopment financially viable. The plan as prepared by Perry-Rose contains the following recommended land uses by planning area (See Attachment A for Planning Area locations).

It is expected that the initial phases of development would occur in Plan Areas A and B, with the possible exception of the Harris School building which may continue to serve the District for several years to come. However, the Harris School building parking lot could serve to provide a shared parking arrangement in the interim to support any of the proposed new development and reuse of the Union High School building. Plan Areas C and D would not commence until such time as the District determined there were no further use for the Crown Pointe Charter School building centrally located on the site. Plan Area E would be expected to redevelop only at such time the market makes it financially viable to pursue, which is anticipated to only occur after the train station at Irving Street and 70th Avenue becomes operational.

Under this phasing scheme, initial development activity at the CEP would involve a limited amount of multifamily development in conjunction with the old Westminster High School building and the Union High School building, about 35 new townhomes, and neighborhood scale commercial space. It would also include the construction of the new pocket park along Lowell that would be complimentary to the development activity anticipated along Lowell Boulevard.

The plan has been presented to the School District Board for their review and comment. The Board was comfortable with moving forward with additional consideration of the plan, with the understanding that considerable additional discussions need to take place before the plan is finalized.

Upon finalization of this land use plan, City staff would further work with District staff to refine timelines and logistics related to making some or all of the property available to the development community. This would include a timetable for vacating the historic buildings. Upon the District finalizing the parameters for a sales transaction, City staff will actively recruit a quality developer(s). The developer(s) then would negotiate directly with the District relative to a sales transaction. Pending a developer securing District property, City staff would then work closely with the developer to prepare a final development plan and proposal for City Council consideration.



SUBJECT: Public Safety Art Project

Summary Statement

This report is for City Council information only and requires no action by City Council.

Background Information

The Public Safety Recognition Foundation (PSRF) has been working for a number of years to design, create, and install a piece of art that would serve as a tribute to all within the community who contribute to the safety of the community. Those to be honored would include citizens, businesses, and City employees including Fire and Police Department personnel. This tribute would be placed in front of the Public Safety Center within the circular stone area that is currently used for plants and flowers.

The PSRF has completed a process to select an artist and has contracted with sculptor Brian Hanlon out of Toms River, New Jersey. Mr. Hanlon has extensive history in creating public safety tributes and with the input of the PSRF has developed a tribute concept for Westminster that includes two larger than life size bronze statues – one uniformed Firefighter and one uniformed Police Officer – and a customized six foot by twelve foot black granite wall with engravings that depict public safety in Westminster. The cost for this tribute will be \$125,000 with an estimated additional cost of approximately \$25,000 for landscaping, lighting, benches, and a stone pathway.

Funding for this project is underway and is primarily based on donations. Willing contributors will get their names inscribed on the back of the granite wall. Other contribution levels as outlined in the attached brochure will secure themselves an inscribed brick that will be used in the landscaping leading to and surrounding the art tribute. Other funding for this project includes proceeds from the Fire Chief Ale event and the Blazing Bullets Trail Run. Finally, some grant monies provided by local businesses are being diverted to this cause. An example would include monies donated by the local Wal-Mart's to the Fire Department that will be used to fund this project.



This project supports the established strategic plan under two goal areas. First, this project should maintain and enhance employee morale under the goal of a "Financially sustainable city government providing exceptional services." Second, this project will promote strong community events and active civic engagement under the goal of "Vibrant neighborhoods in one livable community." It should also be noted that this project has a direct link to the goal of "Safe and secure community" although it is not linked to one of the established objectives.

City Staff and members of the Public Safety Recognition Foundation will be present at the February 7, 2011 Study Session to provide an overview of this tribute project and review the fund raising efforts that are currently in place.



Background Information

The following report is a listing of City Council expenditures by each account for January 1 through December 31 as posted by January 24, 2011. As of December 31, 2010, 100% of the year elapsed and Council spent approximately 85%, or \$189,108 of its amended 2010 budget. At the present time, City Council's amended 2010 budget has a year-end balance of \$33,203.

As the Finance Department finalizes the books by performing standard auditing procedures, minor adjustments may be made to City Council's accounts.

Overall, there are healthy remaining balances in most of City Council's budget accounts. City Council did overspend one budget account. City Council expended \$8,911 in its Meeting Expenses account, which had an amended 2010 budget of \$7,750. This represented \$1,161 in expenditures over budget. Once again though, adequate balances remain in most other accounts and these funds will cover the additional expenditures in the Meeting Expenses account.

Background Information:

Staff has compiled the attached status report on Capital Improvement Program (CIP) projects for activities through the third reporting period of 2010, ending December 31.

The "Updated" column on the far left side of the attached report will have a mark () in it denoting that the project information (such as the description, status, budget, projected completion date or percent complete) has been updated, or it will have "NEW" typed in to identify any new projects added to the CIP Status Report since last period, or it will have "TO BE CLOSED" typed in to identify projects that have either been closed in the financial management system or about to be closed. If a project does not have a mark designating that an update has been provided, it does not necessarily mean that no work has been conducted on the project during the most recent period; it simply means that nothing substantial enough to report to City Council has occurred that warrants providing an update.

The definition for each of the columns included in the report is noted on the attached document ("Attachment A: Definitions – Capital Improvement Program (CIP) Project Status Report"). <u>The definitions are utilized internally to ensure that staff is reporting information as consistently as possible.</u>

The project name, a brief description of the project, project status, project budget, project expenditures as of December 31, 2010, the project manager(s), engineering firms/contractors, start date, projected completion date and percent complete is provided for each project on the "Capital Improvement Program – Major Projects" pages and "Capital Improvement Program – Ongoing Projects" pages (Attachment B).

The projects are sorted based on whether they are ongoing in nature or have a definitive beginning and completion date. Some projects may include funding from both the General and Utility Funds but are listed only once, reflecting the consolidated total in this report. Those projects on the Ongoing Projects pages do not include a start date, projected completion date or a percent complete due to the nature of these projects (i.e., they are continuing projects from year to year).

Major Projects are expensed each year rather than waiting until each project is substantially complete. As such, for continuity in this report, Staff is reporting the revised budgets for each project, excluding any expensing required by the auditors, so that City Council and the public may see the full cost of the project rather than an annually modified amount that does not accurately reflect the full cost and scope of the project. On the Ongoing Projects pages, the capitalized/expensed amounts will continue to be shown so that City Council and the public may see what funds are actually available for these projects that are continuous in nature.

Staff will continue to provide this report to City Council three times per year on a trimester basis. If City Council has questions about any of the projects included in this report, Staff is available to meet individually with City Council members and provide additional information on the projects included within this document or provide appropriate information as requested.

DEFINITIONS – Capital Improvement Program (CIP) Project Status Report

Updated – The Updated column is intended to simplify the review of the report by drawing attention to those projects with new updates since the last report. The column will have a ▶ mark in it denoting that the project information has been updated, or will include "NEW" to identify any new projects that may have been added since the last report via supplemental appropriations (such as from carryover, the receipt of a grant or the subdividing of a larger project into smaller components), or will include "TO BE CLOSED" if the project will be closed before the next report. If a project does not have a mark designating that an update has been provided, it does not necessarily mean that no work has been conducted on the project since the previous report; it simply means that nothing substantial enough to report to City Council has occurred that warrants providing an update.

Project Title/Description – The Project Title is common name utilized by Staff in identifying the project. The Project Description is a brief description of the project, specifically focusing on the scope of the project for which funds are budgeted (i.e., are the funds appropriated for the full project, from design to construction, or simply the design/engineering component of the project).

Project Status – A brief update as to the progress made on this project, providing information such as how much work has been completed, if the project is on schedule, ahead or behind, if any challenges have developed as a result of contractors or the weather, etc.

Budget – For Major Projects, this is the total amount City Council has appropriated via the current and/or prior years' budgets. Some projects have funding from multiple sources, i.e., the General and Utility Funds; in these cases, the combined total for the project is shown in this report.

For Ongoing Projects, this is the amount that has been entered into the financial management system that City Council has appropriated via the current or prior years' budgets. This amount may be different from the total amount that has been appropriated over the years, since many projects that are ongoing have received funding for many years, in some cases over ten years. Showing the cumulative budget since project inception is not only difficult to gather given the conversion to a new financial management system, but is not representative of the funds actually available to spend on these ongoing projects. Some projects may include open contracts from which some expenditures have been made but the "Spent" column reflects only those actual expenditures, and therefore the associated encumbrances (i.e., financial obligations) are not necessarily reflected in these figures.

Spent – Actual expenditures made to date, *excluding* encumbrances.

Project Manager(s) – The City staff member(s) overseeing the completion of the project. Regardless of having an external project manager, a City staff member will always oversee City projects.

External Project Manager Utilized - This column identifies if the primary project lead is a City staff member or an outside contractor. On complex construction projects of approximately \$3-5 million or more, the City is likely also to hire a professional project manager on a contracted basis (in addition to an independent project construction inspector) to provide overall project management under the direction of City staff. If an external project manager is utilized, the name of the contractor is listed in this column.

Engineering Firms Or Contractors – Lists all outside firms the City has hired to work on this project, excluding the external project manager if applicable.

Start Date – Identifies the month and/or year in which the project was initiated (noted on the Major Projects' pages only).

Projected Completion Date – The projected/targeted date for which the project is anticipated/scheduled to be complete (noted on the Major Projects' pages only).

Percent Complete – Identifies the amount of the overall project, as funded via City Council appropriations and defined in the Project Title/Description that is complete. It is based solely on what has been funded to date and may not include actual completion/construction of the project. There will not necessarily be a one-for-one correlation between the percent complete and the amount expended. (For example, City Council may have funded the design only of a project and based on this funding level, the project may be 75% complete, which would be reflected in the Percent Complete column. However, when looking at the overall project, which might be for the construction of a new bridge, the design component is only 5% of the overall project; however, City Council has not appropriated the construction funds as of yet and therefore this percent complete would remain at 75% until the total project funds are appropriated. Once the entire project budget is appropriated, the percentage complete column would be adjusted to 5%, reflecting the percentage of the total project that the design work represents. Some projects may be 100% complete but may reflect some funds remaining in the project and the project remains on this report due to warranty work that is yet to be completed; once warranties expire, the project will be closed.)

Summary Statement:

This report is for information only and requires no action by the Board. The report represents the unaudited financial position for each of the Westminster Economic Development Authority's (WEDA) Urban Renewal Areas (URAs) as of December 31, 2010.

Background Information:

WEDA currently includes seven separate URA's. This report presents the financial activity as of December 31, 2010 prior to additional year-end adjustments to be made during the audit process. Included in the report are the following for each URA:

- Year-to-date comparative graphs showing three years of <u>operating</u> revenues and expenses and debt service, as of December 31 and
- A chart with an at-a-glance look at the changes in revenues and expenses for comparable reporting periods from 2009 to 2010.



Holly Park URA


Holly Park URA Comparative Revenues vs Expenses as of 12/31/10



- The General Fund and General Capital Improvement Fund loaned \$120,000 and \$1,125,000, respectively, to this URA to fund the capital project for the clean-up of the property to ready it for resale. It is anticipated that the interfund loan will be repaid once the property is sold.
- Interest earnings, the only revenue recorded in this URA to-date, increased slightly in 2010 from 2009.
- The above chart reflects only operating activity. The expense in 2008 was a result of an adjustment to inventory. Since this land is being held for resale, it is considered inventory.
- Due to minimal operating activity in the URA, no comparison table is included.

Mandalay Gardens URA Comparative Revenues vs Expenses as of 12/31/10




- Assessed valuation increased in 2010 from 2009, therefore, property tax increment increased in 2010 from 2009.
 - The sales tax pledge was 1.75% from January 2009 through September 2009 and increased to 3% in October 2009 as part of the bond refinancing. In March 2010, the pledge decreased to 0%, as funds already on deposit with US Bank Trust along with anticipated property tax increment was sufficient to meet debt service requirements in 2010. Therefore, the sales tax increment reported here is the total sales tax increment received by the URA in 2010. The remaining non-increment sales tax of approximately \$2.1M flowed to the City's General Fund.
- Due to the low interest rate earnings environment, the interest earnings on the funds invested at the US Bank Trust are low relative to historic performance.
- Other revenue consists of a payment from the Mandalay Town Center General Improvement District (District) to assist with the repayment of the URA's debt. The decrease in 2010 from 2009 is due to a decrease in the base assessed valuation for the District.
- Year-to-date operating expenses increased in 2010 from 2009 due to the property tax collection fee paid to the county treasurer. This is consistent with higher collections than in 2009.

• Total debt service costs reflect a decrease in 2010 from 2009. This is primarily due to larger fees and principal payments required in 2009 because the bonds converted to bank bonds.

North Huron URA Comparative Revenues vs Expenses as of 12/31/10




- Property tax increment increased as a result of an increase in the assessed valuation due to development in the URA.
- Sales tax increment decreased due to the reduction of the sales tax pledge from 1% to 0% in March 2010. Funds already on deposit with Compass Bank, along with anticipated property tax increment was sufficient to meet debt service requirements for 2010. Therefore, the sales tax increment reported here is the total sales tax increment received by the URA in 2010. The remaining non-increment sales tax of approximately \$4.3M flowed to the City's General Fund.
- Interest earnings increased in 2010 from 2009 resulting from higher escrow account balances as expected with the increase in property tax increment.
- Operating expenses increased due to larger contractual expenses and an increase in the property tax collection fee paid to the county treasurer, consistent with the increase in property tax revenues.

• Total debt service costs reflect a decrease in 2010 from 2009. This is primarily due to larger principal payments required in 2009 because the bonds converted to bank bonds.

South Sheridan URA


South Sheridan URA Comparative Revenues vs Expenses as of 12/31/10



- Receipt of incremental property tax revenues began in 2009. Property tax increment increased in 2010 as a result of an increase in the assessed valuation due to completion of development in the URA.
- Increased retail sales in the area resulted in an increase to the sales tax increment in 2010 from 2009. However, due to debt service and reserve requirements, sales tax increment currently does not flow to the City for this URA.
- Operating expenses increased due to increased EDA expenses and an increase in the property tax collection fee paid to the county treasurer, consistent with the increase in property tax revenues.
- Total debt service costs reflect a decrease in 2010 from 2009. This is primarily due to larger principal payments required in 2009 because the bonds converted to bank bonds

South Westminster URA


South Westminster URA Comparative Revenues vs Expenses as of 12/31/10



- Assessed valuation increased in 2010 from 2009, therefore, property tax increment increased in 2010 from 2009.
- There is no sales tax increment revenue in this URA as the sales tax base was not met.
- Interest earnings decreased in 2010 from 2009 as a result of a lower cash balance due to the reduction of incremental revenue in the URA.
- Debt service costs increased in 2010 from 2009. The original bonds for this URA were issued as variable rate debt. In May 2009, when the letter of credit (LOC) Bank decided not to renew the LOC agreement for the bonds, the City purchased the bonds. The new bonds were issued at a fixed rate that ended up being higher than the variable rate and fees paid in 2009.
- The 4th quarter review of this URA's cash available to fund current obligations, including the pay down the Utility Enterprise Fund loan, resulted in the necessity of the General Fund to transfer \$200,000 from 2009 carryover.

Westminster Center East URA Comparative Revenues vs Expenses as of 12/31/10



- Year-to-date property tax increment has increased in 2010 from 2009 consistent with the increase in assessed valuation for the URA.
- No sales tax increment was realized in 2010 or 2009, as property tax increment was sufficient to
 meet the URA's obligations. All sales taxes collected in this URA continue to flow to the City's
 General Fund.
- Interest earnings increased in 2010 from 2009 as a result of the improved rate of return on the pooled investments.
- Total operating expenses decreased due to decreased EDA expenses netted against an increase in the property tax collection fee paid to the county treasurer, consistent with the increase in property tax revenues.
- This URA has no bonded debt obligations.

- On April 13, 2009, City Council approved Resolution 12, Series 2009, which established the Westminster Center Urban Reinvestment Project Area (WURP) and the Reinvestment Plan.
- Tax increment financing approval was not requested at that time.
- While the above chart reflects only <u>operating</u> activity in this URA, it is important to note that City participation funds of \$23,565,274 have been transferred to the WURP URA for redevelopment capital project expenditures.
- Interest earnings, the only revenue recorded in this URA, increased in 2010 from 2009 due to interest earned on the City's participation funds received in 2010 that have not yet been spent.
- Due to minimal operating activity in the URA, no comparison table is included
