Recall Petitions - Mayor Herb Atchison, Mayor Pro Tem Anita Seitz, Councillor Kathryn Skulley and Councillor Jon Voelz

Monday, December 7, 2020

Background

On Monday, August 31, 2020, Ms. Jessica True submitted a sworn affidavit to the City Clerk's Office, setting forth a specific statement of grounds to circulate recall petitions for Mayor Herb Atchison, Mayor Pro Tem Anita Seitz, and Councillors Kathryn Skulley and Jon Voelz, pursuant to the Westminster City Charter ("Charter") Section 3.18 and Westminster Municipal Code Section ("W.M.C.") 7-1-10.

Petitions were approved as to legal form on September 1, 2020. The form submitted for approval totaled 19 pages, and named Ms. Jessica True, Mr. Gary Shea, and Ms. Debbie Teter as the representatives of all petition signers. It is worth noting that the approved form contained a signature page in which line number 59 was repeated; page 12 ends with signature line 64 and page 13 begins with signature line 75. While the final signature page (page 17 of 19) ends at signature line 104, each petition could contain a maximum of 96 signature lines.

The deadline to turn in signatures was 60 days from the date the petition was approved as to legal form by the City Clerk's Office, which was Saturday, October 31, 2020, as required by Charter section 3.18, W.M.C. 7-1-10(d), and Colorado Revised Statutes ("C.R.S.") Title 31, Article 4, Part 5.

The required number of signatures to trigger a recall election for Mayor Herb Atchison is an amount equivalent to 25 percent of all votes cast in the last municipal election for that office, or 5,009 signatures. The required number of signatures to trigger a recall election for Mayor Pro Tem Anita Seitz, and Councillors Kathryn Skulley and Jon Voelz is an amount equivalent to 25 percent of the total votes cast for those offices at the last municipal election, divided by the number of open seats (3), or 6,098 signatures.

On Friday, October 30, 2020, the City Clerk's Office received four petitions from Ms. Jessica True, accompanied by three other individuals. Each petition was filed as a single instrument pursuant to Charter Section 3.18 and W.M.C. 7-1-10, and thus no subsequent filings could be accepted as part of the same petition after this date.

The City Clerk's Office released a Certificate of Initial Determination of Insufficiency on Friday, November 13, 2020.

Pursuant to C.R.S. 31-4-503(3)(b) a protest hearing was held on November 20th, 2020 at the conclusion of which the hearing officer issued an order making no changes to the previously issued certificate.

Withdrawal of Petitions and Subsequent Filing of Amended Petitions

On Wednesday, November 18, 2020, all petitions were withdrawn by the petition committee. Four petitions were refiled with the City Clerk's Office on Monday, November 30, 2020. In

addition to the original petition sections, the petition committee submitted 8 new petition sections for each recall petition instrument. See Figure 1, below.

Four separate Certifications of Documents Filed were issued to the petition committee to acknowledge the amended filings. See Attachments 1 - 4, Certifications of Documents Filed.

In addition to the amended petitions, the petition committee also submitted:

- Sworn affidavit from Debbie Mac Master Teter;
- Exhibit 1 from Deborah Mac Master Teter, in hard copy and copied to a flash drive;
- Sworn affidavit from Jessica True:

- Sworn affidavit from Sandra Pospisil.

Upon receipt of the petition filings, the City Clerk's Office began processing the petition sections one by one, reviewing the affidavits submitted to cure previously disqualified sections, and examining the Exhibit 1 document line-by-line.

As a means of curing individual signature lines, a spreadsheet was submitted by the petition committee detailing reasons each line should be reexamined and accepted as valid, and in some cases providing additional information to be considered. The City Clerk's Office reviewed each of the 404 lines submitted, which resulted in 317 signature lines being cured, and 86 signature lines remaining invalid. One line submitted to cure had already been previously deemed valid, and thus, no further action was taken. See Attachments 10 - 13 for details of the final disposition of the line-by-line verification of Exhibit 1.

Previously Disqualified Sections Now Cured

Issues with Affidavit of Circulator

Circulator affidavits were submitted for 9 petition sections, and all 9 sections were deemed cured by the City Clerk's Office in accordance with C.R.S. § 31-4-503(3)(c).

The City Clerk's Office accepts the submitted affidavit on this point as having properly cured the faults of the originally submitted sections containing irregular circulator affidavits.

The 9 cured petition sections were processed for line-by-line registered elector verification. See Figures 11 – 14, below, for details of the final disposition of each of the recall petitions, including the cured petition sections.

Sections with Evidence of Disassembly

While evidence of disassembly having the effect of separating the signature sheets from the affidavits appeared in the originally filed petition sections, the City Clerk's Office accepts the submitted affidavits on this point as having properly cured the faults of the originally submitted sections containing evidence of disassembly, by providing a plausible showing and alternate explanation of the existing evidence, that signature pages were never actually separated from the affidavit.

Previously Disqualified Sections for Removal of Cover Pages

Certain petition sections were initially disqualified because:

- 1. the addition of a cover sheet renders that section different than the submitted and approved form and thus invalid under C.R.S. 31-4-502(1)(c);
- 2. the addition of a cover sheet rendering the top of each section without the required warning language or the exact statement of charges previously filed with the City Clerk and makes that section invalid under W.M.C. § 7-1-10; and
- 3. the addition of a cover sheet means that the section included a page that did not contain the warning language or the exact statement of charges previously filed with the City Clerk and thus invalid under W.M.C. § 7-1-10, and C.R.S. 31-4-502(1)(a)(II).

None of the sections disqualified for these reasons has been effectively cured, and thus they remain disqualified.

The substantial compliance test has, as of yet, not been held to be the governing standard for evaluating recall petitions, even though the Colorado Supreme Court has had the opportunity to so rule. "We have applied the substantial compliance standard to alleged violations of election statutes, but we have not imported this standard into our constitutional jurisprudence on this subject [of recall elections]." Jones v. Samora, 318 P.3d 462, 470 n.6, as modified on denial of reh'g (Feb. 24, 2014) (internal citation omitted). Until the Supreme Court rules otherwise, the existing standard set forth is that while the "power of the people to use the recall procedures must be liberally construed and that, conversely, limitations thereon must be interpreted strictly. Nevertheless, to liberally construe the statutes governing the exercise of the power to recall is not to ignore entirely the requirements of those statutes." R.E.C.A.L.L. (Residents Extremely Concerned About La Plata's Leadership) v. Sauer, 721 P.2d 154, 155 (Colo. App. 1986) (internal quotes and citations omitted);

Neither the substantial compliance test (were a court to apply it to recall elections as they have not yet done), nor the requirement to liberally construe the right to recall, allows the City Clerk to ignore the plainly stated requirements of W.M.C. § 7-1-10, as well as C.R.S. 31-4-502(1)(a)(II) and (c). *Id.*; *Hazelwood v. Saul*, 619 P.2d 499 (Colo.1980); *Mirandette v. Pugh*, 934 P.2d 883, 884-85 (Colo. App. 1997); and *Jones*, 318 P.3d at 470 n.6.

The City Clerk is required to obey the City Charter, City Code, Colorado Revised Statutes, and existing case law on the subject, and thus has no choice but to disqualify these petition sections.

These petition sections were not disqualified because they showed evidence of disassembly in violation of C.R.S. § 31-4-503(2)(d), and thus, an affidavit attesting that the signature pages were not separated from the affidavit offers no cure.

Petition Sections Containing an Additional Inserted Page

Certain petition sections were initially disqualified because:

- 1. the addition of a cover sheet renders that section different than the submitted and approved form and thus invalid under C.R.S. 31-4-502(1)(c);
- 2. the addition of a cover sheet means that the section included a page that did not contain the warning language or the exact statement of charges previously filed with the City Clerk and thus is invalid under W.M.C. § 7-1-10, and C.R.S. 31-4-502(1)(a)(II).

None of the sections disqualified for these reasons has been effectively cured, and thus they remain disqualified.

The substantial compliance test has, as of yet, not been held to be the governing standard for evaluating recall petitions, even though the Colorado Supreme Court has had the opportunity to so rule. "We have applied the substantial compliance standard to alleged violations of election statutes, but we have not imported this standard into our constitutional jurisprudence on this subject [of recall elections]." *Jones*, 318 P.3d at 470 n.6. Until the Supreme Court rules otherwise, the existing standard set forth is that while the "power of the people to use the recall procedures must be liberally construed and that, conversely, limitations thereon must be interpreted strictly. Nevertheless, to liberally construe the statutes governing the exercise of the power to recall is not to ignore entirely the requirements of those statutes." *R.E.C.A.L.L.*, 721 P.2d at 155:

Neither the substantial compliance test (were a court to apply it to recall elections as they have not yet done), nor the requirement to liberally construe the right to recall, allows the City Clerk to ignore the plainly stated requirements of W.M.C. § 7-1-10, as well as C.R.S. 31-4-502(1)(a)(II) and (c). *Id.*; *Hazelwood*, 619 P.2d 499; *Mirandette*, 934 P.2d at 884–85; and *Jones*, 318 P.3d at 470 n.6.

The City Clerk is required to obey the City Charter, City Code, Colorado Revised Statutes, and existing case law on the subject, and thus has no choice but to disqualify these petition sections.

These petition sections were not disqualified because they showed evidence of disassembly in violation of C.R.S. § 31-4-503(2)(d), and thus, an affidavit attesting that the signature pages were not separated from the affidavit offers no cure.

Petition section number 105 in the petition to recall Mayor Pro Tem Anita Seitz, was noted as containing petition pages out of order, but was ultimately rejected due to the insertion of a partial additional page. A sworn affidavit of the petition circulator, Nancy I. Hastings, was submitted by the petition committee, but Ms. Hastings states in the affidavit that she does not know how the partial page was inserted. Her statement offers no acceptable cure for the existence of the additional partial page. See Attachment 14.

Additional signatures gathered after the 60-day petition circulation period

Signatures gathered more than sixty days after the petition and affidavit of charges were approved as to form cannot be accepted.

Westminster City Charter § 3.18 states that "A petition demanding the recall of the officer sought to be removed and signed by registered electors equal in number to twenty-five (25) percent of all votes cast for all the candidates for that particular office at the last preceding regular election [...], shall be [...] delivered to the City Clerk not more than sixty (60) days after the affidavit making charges against said officer has been filed." W.M.C. § 7-1-10(D) states that "The petition shall be filed in the office of the City Clerk not more than 60 days after the affidavit making charges against said officer has been filed." C.R.S. § 31-4-503(2)(a) states that "[a]II such recall petitions shall be filed in the office of the municipal clerk within sixty days from the date on which the municipal clerk approves the petition as to form."

The provisions of Title 31, Article 4, Part 5 "shall apply to all municipalities <u>except to the extent</u> that a municipality has adopted provisions pursuant to article XX or XXI of the state constitution inconsistent with this part 5." C.R.S. § 31-4-501 (emphasis added). Where a local provision and Part 5 can be read in harmony, they are both effective, and where there is no conflict Part 5 is still in full force and effect alongside the local provisions.

Westminster Charter § 3.18, W.M.C. § 7-1-10(D), and C.R.S. § 31-4-503(2)(a) all agree in clearly stating a 60-day deadline after the affidavit making charges was filed for the gathering and submission of signatures. There is no conflict between any of these provisions, and nothing which could reasonably be interpreted in the Westminster Code or Charter which would overrule C.R.S. 31-4-503(2)(a) and allow for the gathering and submitting of additional signatures long after the sixty-day deadline. Even if there were some clear and unambiguous statement in the Westminster Code that explicitly overrode the sixty-day deadline in Part 5 (which there is not) no such provision in the Westminster Code could override the sixty-day deadline contained in the Westminster Charter.

Furthermore, no conflict exists between the provisions of the Westminster Municipal Code and the Colorado Revised Statutes with regards to withdrawal and amendment of petitions.

The basic principles of statutory interpretation are long established and well known. "In construing statutes, our primary duty is to give full effect to the intent of the General Assembly. Accordingly, we start with the plain language of the statute, because if courts can give effect to the ordinary meaning of the words adopted by a legislative body, the statute should be construed as written since it may be presumed that the General Assembly meant what it clearly said[.] Additionally, a statutory interpretation leading to an illogical or absurd result will not be followed, and we strive to construe a statute as a whole in order to give consistent, harmonious and sensible effect to all of its parts[.]" Colorado Water Conservation Bd. v. Upper Gunnison River Water Conservancy Dist., 109 P.3d 585, 593 (Colo. 2005) (Superseded by statute on unrelated grounds) (internal citations, quotes, and ellipsis omitted). "If separate clauses in the same statutory scheme may be harmonized by one construction, but would be antagonistic under a different construction, we should adopt that construction which results in harmony."

Mountain City Meat Co. v. Oqueda, 919 P.2d 246, 253 (Colo.1996). "We will not judicially legislate by reading a statute to accomplish something the plain language does not suggest, warrant or mandate." Scoggins v. Unigard Ins. Co., 869 P.2d 202, 205 (Colo.1994)

C.R.S. § 31-4-503(3)(c) provides that "In case the recall petition is not sufficient, it may be withdrawn [...] and, within fifteen days after the municipal clerk or hearing officer issues a written determination that the petition is not sufficient, may be amended by the addition of any required information relating to the signers thereof or the attachment of proper circulator affidavits and refiled as an original petition; except that any petition amended and refiled as provided in this paragraph (c) may not again be withdrawn and refiled." C.R.S. § 31-4-503(3)(c) does not provide for amendment by the addition of signatures gathered after the explicitly stated sixty-day deadline. W.M.C. § 7-1-10(D) provides that "The petition may be withdrawn and amended within 15 days from the filing of the certificate [of insufficiency]." These two provisions are entirely consistent in providing for withdrawal and amendment within a 15-day time period. No conflict exists.

C.R.S. § 31-4-501 clearly states that the provisions of the C.R.S. apply except to the extent that there are conflicting provisions in the W.M.C., therefore the procedures for amendments in the C.R.S. apply where there is no conflict. Reference to a 15-day amendment process in W.M.C. § 7-1-10(D) is an obvious reference to, and in no conflict with the 15-day amendment process in C.R.S. § 31-4-503(3)(c).

The City cannot adopt an interpretation of the 15-day amendment process in W.M.C. § 7-1-10(D) as establishing an entirely new and undefined petition process which disregards the explicit rules, procedures, and deadlines contained in the Westminster Charter, Westminster Municipal Code, and Part 5 of Article 4 of Title 31 of the Colorado Revised Statutes. Particularly when the true intent of the language is clearly intended to be, and easily interpreted in harmony with all of these provisions and restrictions.

What is being considered here is not a new petition, but a legally prescribed method for curing an existing petition. The affidavit for this petition was filed on August 31st, 2020 and approved as to form on September 1st, 2020. The sixty-day period for the gathering of signatures ended and the petition was properly filed on October 30th, 2020.

The number of valid registered elector signatures stands at 4,917 and does not meet the required number of 6,098 signatures needed to trigger a recall election. Therefore, the Petition to Recall Councillor Jon Voelz is found to be insufficient.

Conclusion

Upon amendment and subsequent refiling of the four recall petitions, the final disposition of all sections and all lines submitted for potential cure results in an insufficient number of valid electors to trigger a recall election for Mayor Herb Atchison, Mayor Pro Tem Anita Seitz, Councillor Kathryn Skulley, or Councillor Jon Voelz.

- 1. I am a member of the committee seeking to recall Kathryn Sculley, Jon Voelz, Anita Seitz, and Herb Atchison. As a member of the committee, I have helped organize and manage the review of signatures that were rejected by the Westminster City Clerk.
 - 2. I, along with other volunteers, reviewed each rejected signature.
- 3. As part of our review, we used the following two databases to compare voter names and addresses:
 - a. The Jefferson County voter database. We received this on November 19, 2020, from Marcela Billingsley, an employee of the Jefferson County Clerk and Recorder.
 - b. The Adams County voter database. We downloaded this from Downloaded from https://www.adamsvotes.com/records-and-data-2/voter-lists/ on November 19, 2020.
- 4. In order to verify that addresses were within the City of Westminster, we relied upon the following sources:
 - a. The Annexation Map of Westminster, available at: http://www.arcgis.com/home/webmap/viewer.html?webmap=5b23e b80a1ec4211ab46f722b13841d7&extent=-105.2828,39.7534,-104.7411,40.0257
 - b. Searches of Jefferson County property records, at: https://propertysearch.jeffco.us/propertyrecordssearch/dashboard
 - c. Searches of Adams County property rearch at: https://www.adcogov.org/property-look
 - 5. Each rejected signature was matched to the voter database based on:
 - a. First Name
 - b. Last Name
 - c. House Number

d. Street

- 6. Exhibit 1 contains the result of our searches. Specifically, it includes the voter information, the reason for rejection, and additional information showing that the signature should be accepted by the Clerk.
 - 7. The additional information includes the following categories:
 - a. Voters used common nicknames in their signature, rather than the formal name contained in the voter database.
 - b. Voters used their middle name in their signature, rather than the first name contained in the voter database.
 - c. The voter database contained a formal name, and the voter used a common variant in their signature.
 - The voter database contained an informal name, and the voter used a formal variant in their signature.
 - Voters used a hyphenated name in the voter database, but used a nonhyphenated version in their signature.
 - f. Voters used a non-hyphenated name in the voter databased, but used a hyphenated version in their signature.
 - g. A mailing address on the voter registration matched the voter's address on their signature line.
 - h. The city or county could be deduced, because only one city or county in the State of Colorado matched the voter's address. In other words, there was no question that the voter resided in the proper city or county. the voter address only one city or county existed in the State of Colorado.
 - Voter names rejected as "illegible" were in fact legible and could be matched to a voter record.
 - Unique names could be properly matched to a valid Westminster voting address.
 - Female voters signed using a married name, rather than the nonmarried name in the voter database.

After this, the circulator completed a new affidavit, attesting to the fact that the circulator collected signatures in accordance with all legal requirements.
- 4. I took those completed affidavits and clipped the affidavit to the original petition sections. I followed that procedure so that we could securely attach the new affidavit to the existing petition section without disassembling or altering the original petition section.
- 5. The committee has maintained careful control over all petition sections, and none of the new affidavits have become separated from the original petition sections.

- 4. After I collected signatures and finished with a petition section, I kept the petition section together.
- At no time did I remove pages from any petition section.
- 6. After collecting signatures, I took my petition section to a notary public. In front of a notary public, I affirmed that I had personally collected each signature in the petition section. That affidavit is part of the petition section that I reviewed.
- 7. I have reviewed the section that I circulated. It is the exact section, except for two items. First, some of the pages are out of order. Second, there is a partial page. I do not know how the pages got out of order, or how the partial page was inserted.
- 8. Even though the pages are out of order, I collected each and every one of the signatures in that petition section.

9. After signing each petition section before a notary public, I handed my petition sections to a representative of the recall committee.
