Summary of proceedings of the Westminster City Council meeting of Monday, March 25, 2024. Mayor McNally, Mayor Pro Tem Nurmela (virtual), and Councillors Carmelia, DeMott, Ezeadi, Hott, and Ireland were present at roll call.

The minutes of the March 11, 2024, meeting was approved as written.

Council presented the following: Child Abuse Prevention Month Proclamation; Colorectal Cancer Awareness Month Proclamation; and Persian New Year Proclamation.
