

Residential Building Permit Requirements

Always check with your HOA and Planning Division before undertaking any project.

Permits **ARE** required for the following types of projects: **Outside**

- Decks over 30 inches above ground level
- Any deck with an attached roof
- Patio covers, awnings (non retractable), carports
- Storage sheds larger than 120 sq feet
- Fences
- Retaining walls greater than 3 feet or with surcharge
- New lawn sprinkler systems
- Pools (with water depth greater than 24 inches), spas, hot tubs, fountains and other similar installations
- Roofing installation or replacement
- Siding and stucco (other than minor repair)
- Room additions
- Attached and detached garages
- Accessory buildings larger than 120 sq feet
- Evaporative (swamp) cooler installation or replacement
- Air conditioner installation or replacement
- Patio enclosures & screened porches
- Gas lines
- Interconnected electric power production sources such as generators, solar/photovoltaic, wind and fuel cell systems (all areas)
- Installation of new or altered electrical service equipment, including service entrance, feeder, or branch circuit conductors (all areas)
- Underground repair/replacement of sewer/water lines
- Underground electric over 50 volts for landscaping
- Outside BBQs & kitchens

Inside

- Installation or replacement of HVAC equipment, including boilers, water heaters, furnaces, and tankless water heaters
- Whole house water softener systems
- Gas logs & gas lines
- Fireplace/inserts (wood, pellet or gas)
- Remodeling and basement finishes
- Modifications to electrical, plumbing, mechanical and/or structural systems
- Electric to gas conversions
- Installation of additional windows or doors, increase or decrease of window or door size

Permits **ARE NOT REQUIRED** for the following types of projects:

Outside

- Decks not more than 30 inches above ground*
- Stand alone storage sheds 120 sq feet or less with no electrical, plumbing, or mechanical*
- Gazebos 120 sq feet or less with no electrical, plumbing, or mechanical*
- General landscaping
- Concrete sidewalks and driveways on private property
- Concrete porches (without roofs not more than 30 inches above ground)
- Painting
- Minor roofing repair (100 sq feet or less)
- Repair or maintenance of existing fences
- Retaining walls 36 inches or less in height when measured from ground level on the low side to the top of the wall with no surcharge*
- Portable heating, ventilating, and cooling appliances
- Portable wading pools with water depth < 24 inches
- Minor siding repair (less than 100 sq feet)
- Swings or other playground equipment
- Landscape/yard décor electrical less than 50 volts
- Expansion of existing lawn sprinkler system

Inside

- Painting
- Floor covering
- Wallpaper
- Replacing plumbing fixtures (but NOT RELOCATING plumbing fixtures)
- Replacing cabinets and counter tops (note that if configuration of cabinets change from original configuration an electrical permit MAY be required)
- Changing light fixtures (but not relocating light fixtures)
- Repair or replacement of electrical switches, receptacles, and/or circuit breakers
- The clearing of stoppages or the repair of leaks in pipes, valves, or fixture drains, provided no relocation of pipes or valves
- Adding or replacing insulation provided NO OTHER work is being done
- Window replacements of the same size

*Please note that Planning approval may be required for projects constructed on your property. Please contact the Planning Division at 303-658-2092 before you proceed with any exterior alteration.
