LOCAL AGENT (owner or manager resides/lives over 50 miles from dwelling)

The City of Westminster requires all owners of residential rental dwellings to assign a Local Agent to receive legal service of process. Owners residing or operating a permanent place of business in Westminster, or within a fifty (50) mile radius of the rental property, may designate themselves. Owners who do not reside or operate a permanent place of business in Westminster (or within a fifty (50) mile radius of the rental property) MUST designate a Local Agent who resides or operates a permanent place of business within a fifty (50) mile radius of the rental property. A local agent may include but is not limited to a designated family member, friend, or tenant.
