| Splash pads | Operate Memorial Day weekend through Labor Day weekend 9 a.m. to 7 p.m. These may be shut off at any time during the season due to weather, maintenance, or other operational concerns. Dogs are not allowed in water play features. |
| Rental Hours | All rentals are 10:00am-8:00pm. No hourly rentals will be provided. |
| Inflatables/Tents | Inflatables and large tents are not allowed in any City of Westminster park. Tents 10ft x 10ft and smaller are permitted. |
| Alcohol | <p>Beer and wine are only allowed at City of Westminster Parks when an alcohol permit is purchased for \$50. A driver' license is required to show proof of age. The name of the ID must match the name on the reservation. Alcohol cannot be served in a glass container and kegs are not allowed.</p> <p>Alcohol permit holder is responsible and assumes all risk regarding liabilities that may arise by those attending and drinking alcohol during the rental. Applicant is responsible for ensuring that all persons who drink are of legal age and all state alcohol laws are obeyed. Applicant must be on site during rental and keep approved permits on hand at all times.</p> |
| Grill Use No propane tanks allowed | If a grill is provided in the park renters may use it. However, grills cannot be brought into City of Westminster Parks. |

| Pavilion Area and Parks | Pavilion rental is for the pavilion area only. Parks and playgrounds are open to the public. |
| Animal Restrictions | All animals must remain on a leash at all times. |
| Cancellation Process | \$10 cancellation fee assessed with a minimum 15-day prior notice to scheduled event. After 15-day period no refunds are issued. |
| Electricity | Electricity is provided at parks, outlets are 15-20amps. On occasion, outlets at pavilions may be out of order. |
| Music & Amplified Sound | Amplified music is not allowed in City of Westminster Parks |
| Restroom Access | All pavilions have either a restroom or a port-a-let. Should a restroom be out of service, a port-a-let will be provided. |
| Selling of Items | Selling of items is not allowed in City of Westminster Parks |
| Inclement Weather | Refunds will not be issued due to weather. However, reservations can be rescheduled based on availability. |
| Reservation Age Requirements | Renters must be 21 years old to reserve a pavilion. |
| Pinatas | Pinatas are not permitted in City of Westminster parks. |
| Parking | Designated parking is available at some of the parks, and is available first come first serve to all park users. The majority of the parks have limited street parking and it is recommended that large groups carpool. |
| Permits | After completing the reservation process renters will receive a receipt, this receipt will serve as the permit for the City of Westminster Park reservation. |
